Applications are OPEN for the Summer 2024 OSSE Consortium Dual Enrollment Program! Through Dual Enrollment, DCPS students can take challenging college courses that are not offered at their home high school while earning college credit that can be transferred to many postsecondary institutions. Tuition and textbook costs are waived for accepted students in the OSSE Consortium program!

### Eligibility Requirements:

Currently enrolled 9-11th grade DCPS students can apply for summer semester programming!

When completing the online application, the application will only populate schools the student is eligible to apply to based on their entered GPA and DCPS grade-level.

When applying to the OSSE Consortium Dual Enrollment program, students are required to rank their college/university preferences. Before starting the application, please take a look at the [course offerings](#), considering class meeting formats and subject areas offered.

**NOTE:** Students currently enrolled in a Spring 2024 Dual Enrollment course do not need to reapply for Summer Semester Dual Enrollment!

### How to Apply?

**Step 1)** Request and prepare the following documents:

- DCPS high school transcript [GPA must be included]

*\*10th and 11th grade students applying to UDC or Community Colleges within the OSSE Dual Enrollment program are not required to provide an essay or teacher recommendation form.*

*\*9th grade students applying to NOVA Community College are required to submit an essay.*

**Step 2)** Visit [bit.ly/OSSEConsortium](https://bit.ly/OSSEConsortium) to complete Part 1 of the DC Dual Enrollment application.

**Step 3)** After completing Part 1, click “**SAVE & CLOSE**” to come back to the application later OR (if you have all required documents ready) immediately complete Part 2 of the application and click “**SAVE & CLOSE**”.
